- Outcome is a temporary solution through a budget clean up bill requiring the Fire Marshal to apply the fire code as it existed on Dec. 31, 2022 for inspections until Dec 31, 2026. The state fire marshal must work with CDSS to development new regulations by January 1st 2027, the law only applies to applicants seeking an updated fire clearance.
