6. Comprehensive Countywide Child Care Plan Draft (Action Item)

A copy of the Comprehensive Countywide Child Care Plan Draft was included in meeting packet.

- Sheri gave a brief overview of the 5-year plan that falls inline with the Needs Assessment. The plan outlines an Executive Summary, Vision and Mission statements, 3 Goals (including measurable goals) with their descriptions and the activities needed to achieve each goal, closing with an overall summary. Goals for the 2025 – 2030 plan will be:
 1. Promote Early Care & Education
 2. Advocate for an Inclusive Child Care System
 3. Identify Opportunities for Families
- Sheri noticed some grammatical errors and they will be addressed.
- Sheri asked the Council to review and give any feedback.
- Council likes “Measurable Goals” as it will show progress that was achieved.
- Suggestion was made to reword Goals #2 description to “continued after-school programing” vs. after-school care
- A suggestion to enlarge the font was made for easier reading
- It was asked where the plan is presented and Sheri stated that it will next go to the Board of Education and Board of Supervisors.
- Sheri had a question for the Council in regards to Goal # 3. Should she change the goal to Identify Opportunities for Families and Providers? Council agrees to include Providers as the “Activities” tie the two in together.
- Overall the Council was very pleased with the Comprehensive Countywide Child Care Plan and the work Sheri has put into the project.
- Sheri will make changes to the draft and bring to the next meeting.

7. Survey Results from Calaveras ECE Students Involved in K-16 Pathways (Action Item)

Copies of the Survey Responses were included in the meeting packet.

- Sheri stated that there will be a small amount of money left over this year from Amador College Connect, so a survey was sent to the students to see how they would like to see that money spent.
- Answers varied, but several students asked for Laptops since they were doing their homework on their phones and find it very challenging. Textbooks were also requested, although most seem to be available now online for free. Others asked for gas cards to assist with travel.
- Funds are unrestricted but needs Council approval on how to spend them.
- The suggestion was made to give the students gift cards so they can use the money towards what they need.
- Another suggestion was to ask each student individually what they would want based on a list of suggested items or a set dollar amount.
- It was clarified that the money was only available to the students in this program.
- A motion was made to move forward with a set dollar amount and list of suggested items such as a laptop, gas card, staples gift card, etc..

 - Council praised Alissa and her team for all of their hard work.
- Jeanette let the Council know that they are fully staffed
 - Funded through May
- Rochelle said there will be a Spring Event April 18th at Ironstone
- TK Kits, which included items like pencils, crayons, scissors and TK readiness books were distributed to all schools.
- Sarah mentioned that the upstairs area should be open by this coming school year, bumping them up to 30 kids. Just waiting for sheetrock.
